SOUTHERN BAPTIST CONFERENCE OF THE DEAF

 HISTORY	ΟF	SBCD	

The first annual meeting was held at First Baptist Church of Memphis in December 1948. It was called "Baptist Workers Conference for the Deaf". Messengers traveled by train from Texas, Georgia, North Carolina, Kentucky, Oklahoma, Arkansas, and Tennessee.

In 1951, it was "Southwide Conference of Baptist Deaf" and also "Southwide Baptist Conference for the Deaf". In 1952, it was "Southern Baptist Conference of the Deaf". It was clearly that the name was officially changed to "Southern Baptist Conference of the Deaf" in 1954 and it has carried the name of our organization ever since.

PURPOSE OF SBCD

- 1.) To provide a vehicle for obeying the Great Commission (Matthew 28:19-20) with respect to deaf people by personal witnessing, evangelism, home missions, foreign missions and discipleship.
- 2.) To provide opportunities for training in local church settings, in state conferences, and on the national level to help equip people in all aspects of the deaf ministry.
- 3.) To serve as a liaison between the Southern Baptist Convention (SBC) and deaf persons, interpreting the needs and functions of the one to the other.
- 4.) To provide a channel of communication within the Southern Baptist deaf community.
- 5.) To provide an understanding of deafness and of the needs of deaf people to the community at large.
- 6.) To provide opportunities for inspirational worship experiences.
- 7.) To provide opportunities for Christian fellowship.

President Anna explained that next year we will celebrate our 75th anniversary. We might make pictures to show history or use the funds to have a big celebration.

President Anna Austin made a motion to vote to accept the proposed budget for SBCD 2023.

Bob Moore, NC: Explained the Board's role is to plan for future conference themes. In three years, (SBCD 2025), our theme will be "Press on! Remaining Steadfast Through Challenging Times, James 1:12".


President Anna Austin made a motion to accept the theme and called for a vote.

Educational Committee Report:

This year we had a wonderful year with the Educational Committee. Nina Coyer, KY, Liz Rentner, TX, and I served on the committee and worked together for the last 5 years. Thankful for all of the video calls and zoom calls and work during that time. I am here to report the finances from the educational committee. We gained a small amount of interest each month. We give \$500 for the Ephphatha scholarship. SBCD gives that fund every year. With those funds, we have invested some and have those funds accruing interest. We lost some investments due to COVID, but we have seen some gains since then. That is positive news. You can see the gains from last year. Two students went through the application process with DTC, but because of COVID, they had to withdraw from the process. Beginning in the fall, we will begin to look for new potential applicants. By this fall, we would like to see if someone could assist us with setting up an Ephphatha page with criteria listed and they could apply for school for the Spring semester. Our cut off dates are as listed in the report attached. We would like to have a website attached to the SBCD website where you see the scholarship criteria and instructions for the application process in ASL. Tuition keeps going up for colleges, so we need to build up our account for those who might really need tuition relief. If you feel the Lord calling you to help raise funds for students to attend DTC or somewhere else in order to obtain training to become pastors or missionaries, reach out to us. We don't want them to worry about borrowing money. Pray if you would like to give, see how the Lord leads you; we are looking for more donors for this fund.
